Meeting Summary

1. Welcome & Overview (Chabre Vickers)

1pm – 1:20pm

Chabre welcomed the committee and thanked them for their leadership in helping implement Advance Portland.

The committee members and staff each shared one thing they love about Portland by way of introductions.

2. Advance Portland Strategy & Context (Prosper Portland Team) 1:20pm – 2:00pm

Kimberly Branam, Lisa Abuaf, and Shea Flaherty Betin presented an overview of the Advance Portland process and background. The full presentation can be found at <u>www.advanceportland.com/progress</u>.

The team highlighted early implementation activities and celebrated the Enterprise Zone expansion and extension, the downtown business license exemption, and the exploration processes into new tax increment finance (TIF) districts.

Monique Claiborne of Greater Portland Inc. inquired about the timeline for TIF district exploration, and staff outlined the goal of coming back to City Council in October 2024.

Andrew Hoan of the Portland Metro Chamber complimented the rapid response from the City and partners to craft and implement early actions to the plan in the few months since the plan's adoption.

With the presentation and questions concluded, the committee took a five-minute break.

3. Call to Action (Commissioner Rubio)

Commissioner Rubio thanked the committee for agreeing to serve and helping Portland achieve its goal of inclusive economic growth. She noted that each member on the committee was nominated because their expertise and lived experience will be instrumental in helping this committee be effective.

Commissioner Rubio stated that the challenges facing Portland are obviously greater than those articulated in Advance Portland, and that we must continue to make progress on the fundamental preconditions to growth – from addressing our houselessness crisis to increasing community safety across our city. We will continue to work at the city, county, state, and federal levels to address the crises Portlanders are facing and ensure that everyone has an opportunity to thrive and prosper.

She told the committee that their role will be to help implement the priorities in Advance Portland – propel inclusive job growth and innovation, foster equitable wealth creation, create healthy neighborhoods and a Central City, and connect Portlanders to high quality, future ready jobs.

Commissioner Rubio thanked staff and partners for the initiatives that are already underway and noted that she was especially proud of the Housing Production Strategy, the Permitting Task Force, and the TIF district exploration processes both in East Portland and downtown.

She then introduced the interactive group activity where she asked committee members the following questions:

- 1) Where do you see yourself or your organization in the Advance Portland plan?
- 2) Where should we focus in this first year? And,
- 3) What should we know about your work?

Chabre and the Prosper Portland team helped facilitate rotating stations for the four Advance Portland objectives.

Using post-its, the committee wrote where they saw themselves or their organizations playing a role.

Using dots, the committee chose top priorities/areas to discuss or focus on in the first year of the committee's work.

Using post-its again, the committee added additional details with updates/information about their work that the committee should know about or be tracking.
